In July 2004, the American Heart Association honored Senator Hill for his work in advocating for heart healthy legislation, namely the 2004 amendments (SB 1283) to the Idaho Clean Indoor Air Act. Senator Hill attended our Volunteer Leadership Conference in Seattle where he received his award.
