- Item 2.** Enter the date on with the Certificate of Limited Partnership was filed with this office.
- Item 3.** Mark the appropriate boxes for the amendments that you wish to make.
- Item 3a.** Is used if the name of the limited partnership is being changed; indicate the new name on line 3a of the application. Make certain the new name of the limited partnership contains the requirements of Idaho Code § 30-21-302(b). It is advised that you contact the Secretary of State's Office to check the name for availability.
- Item 3b.** Enter the amended street and mailing addresses of the principle office of the limited partnership.
- Item 3c.** Is used to withdraw a general partner; indicate the name of each general partner to withdraw.
- Item 3d.** Is used to add new general partner(s); indicate the name and address of each new general partner.
- Item 3e.** Check this box if the partnership has appointed a person to wind up its activities and affairs.
- Item 3f.** Check this box to make the statement that the limited liability limited partnership is deleted.
- Item 3g.** Indicate by checking in the box whether the limited partnership is or is not a limited liability limited partnership.
- Item 3h.** May be used for such instances as listing additional general partners or limited information or other matters pursuant to 30-24-201(c), Idaho Code.
