Item 1a Enter the exact name of the limited partnership as it currently exists.

Item 2a Enter the date that its certificate of limited partnership was filed with the Secretary of State's Office.

The stated certificate of limited partnership supersede any previously filed certificate of limited partnership and any amendments filed thereafter.

Item 1 Enter the name of the limited partnership. If the name of the limited partnership is being amended, be certain the new name complies with the requirements of section 30-21-302(b), Idaho Code. The new name of the limited partnership must contain the words limited partnership or the abbreviation L.P. or LP. It is advised that you contact the Secretary of State to check for name availability.

Item 2 Enter the amended street and mailing addresses of the principle office of the limited partnership.

Item 3 Enter the name and address of the registered agent. The registered agent is the person designated to receive service of process upon litigation. The registered agent can be either a corporation or limited liability company authorized to transact business in Idaho, or a resident of the State of Idaho. The registered office must be located in Idaho at a street address. The new registered agent must sign accepting such position.

Item 4 Enter the name and address of each general partner.

Item 5 Check this box to make the statement that the limited liability limited partnership is deleted.

Item 6 Indicate by checking in the box whether the limited partnership is or is not a limited liability limited partnership.

Item 7 May be used for such instances as listing additional general partners or limited information or other matters pursuant to 20-24-201(c), Idaho Code.

Item 8 The application must be signed by all general partners. Please identify the name of the signer by typing/printing his or her name in the space provided.

Enclose the appropriate fee (make checks payable to Idaho Secretary of State):

- The filing fee is \$30.00 (\$50.00 if the form is not typed)
- If expedited service is requested, add \$20.00 to the filing fee.
- If the fees are to be paid from the filing party's pre-paid customer account, conspicuously indicate the customer account number in the cover letter or transmittal document.
