1. Line 1 - Enter the name of the limited liability company exactly as it appears in the records of the Idaho Secretary of State.
2. Line 2 - If the limited liability company was required to adopt a fictitious name to use in the State of Idaho to avoid a name conflict, or if the company was required to add an ending to their name to comply with Idaho code, indicate such name on line 2.
3. Line 3 - Enter the date the application for registration of foreign limited liability company was filed with the Idaho Secretary of State.
4. Line 4 - **Item a:** If this amendment is to change the name of the limited liability company indicate the new name of the limited liability company. Note: The new name of the limited liability company must contain the requirements of 53-602, Idaho Code, which requires the name to contain the words Limited Liability Company, Limited Company or the abbreviation L.L.C., L.C., LLC or Ltd. Co. If the new name of the limited liability company is not available, or does not contain an ending which is permissible to Idaho Code, indicate a fictitious name to use in Idaho which meets such specifications. The application must be accompanied by an original certificate from the proper filing officer in the jurisdiction of limited liability company evidencing the name change. Please note that the certificate required is a one page document. A certified copy of the articles of amendment or merger is not acceptable.
Item b: Applies only to a change of jurisdiction pursuant to a statute of the new jurisdiction which permits re-domestication. In such case, the application must be accompanied by an original certificate from the proper filing office in the new jurisdiction of incorporation evidencing the re-domestication.
Item c: Any other amendment would be specified in the "other amendment" area.
5. The application must be signed by a person authorized by the limited liability company. Please specify the name of the signer by typing his/her name below the signature and indicate in what capacity he/she signs.
6. Enclose the appropriate fee:
 - a. The filing fee is \$30.00
 - b. If expedited service is requested, add \$20.00 to the filing fee.
 - c. If the fees are to be paid from the filing party's pre-paid customer account, conspicuously indicate the customer account number in the cover letter or transmittal document.

Pursuant to Idaho Code § 67-910(6), the Secretary of State's Office may delete a business entity filing from our database if payment for the filing is not completed.
