1. Line 1 - Enter the name of the corporation exactly as it reads in the records of the Idaho Secretary of State's Office. If the corporation was required to adopt a fictitious name to avoid a conflict with an existing business, or if the corporation had to designate a corporate ending to comply with section 30-1-401, Idaho Code, enter such name in the second portion of this section (the name which it used in Idaho).
2. Line 2 - Enter the domestic state of incorporation.
3. Line 3, 4 and 5 are statements which are required by Idaho Code.
4. Line 6 - Enter the address to which future service of process may be mailed against the corporation.
5. Line 7 is a statement which is required by Idaho Code.
6. The application must be signed by an officer of the corporation. Please specify the name of the signer by typing his/her name below the signature and indicate in what capacity he/she signs. (For example: President, Secretary, etc.)
7. Enclose the appropriate fee:
 - a. If the form is typed, the filing fee is \$20.00.
 - b. If the form is not typed, the filing fee is \$40.00.
 - c. If expedited service is requested, add \$20.00 to the filing fee.
 - d. If the fees are to be paid from the filing party's pre-paid customer account, enter the customer account number in the indicated space.
