

# 2016 Write-In Candidate Filing Guidelines

## May 17, 2016 Election

### **Districts scheduled to hold Candidate Elections:**

Port District Primary Election  
Regional Airport Authorities

### **Filing Deadline:**

Declarations and Petitions of Candidacy must be submitted to the Clerk or Secretary of the District between 8 am on the 12<sup>th</sup> Monday preceding the Primary Election and 5 pm on the 10<sup>th</sup> Friday before the Primary Election (February 29 through March 11, 2016).

**Declarations of Intent for Write-In candidates** must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 45<sup>th</sup> day before the Election (April 1, 2016).

### **Withdrawal Deadline:**

Candidates may submit a Notarized Statement of Withdrawal to the Clerk or Secretary of the District no later than 5 pm on the 45<sup>th</sup> day before the Election (April 1, 2016).

## November 8, 2016 Election

### **Districts scheduled to hold Candidate Elections:**

Community College  
Port District General Election  
Soil Conservation Districts

### **Filing Deadline:**

Declarations and Petitions of Candidacy must be submitted to the Clerk or Secretary of the District no later than 5 pm on September 1<sup>st</sup>.

**Declarations of Intent for Write-In candidates** must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 45<sup>th</sup> day before the Election (September 23, 2016).

### **Withdrawal Deadline:**

Candidates may submit a Notarized Statement of Withdrawal to the Clerk or Secretary of the District no later than 5 pm on the 45<sup>th</sup> day before the Election (September 23, 2018).

## Special Districts: Required Forms for Filing for May or November Elections:

### Declaration of Candidacy – Form EC-2A

1. Print name of the Candidate.
  - a. Enter the Office Title, Election and Date of Election, and Candidate Residence Address.
2. Signature of Candidate must be notarized.
